Direction For Use:

Preparation- Surfaces must be clean, dry, and free from any contaminants liable to impair adhesion. Slight moistening of substrates improves curing rate and gap filling characteristics as the adhesive foams up to penetrate cavities and uneven surfaces. During application wear disposable gloves to avoid skin contact and use clamps or mechanical fasteners tools to bond the substrates.

Method of Application

Open the glue bottle cap and remove inner seal and place the cap back. Twist opens the nozzle / cone tip closer and apply adhesive by squeezing the bottle. The glue can be spreader with a brush or an adhesive comb, join the parts and compress for 20-40 minutes. Close the nozzle closer tight and wipe it clean with a towel after each application. Application temperature $+5^{\circ}$ C up to $+35^{\circ}$ C.
